Background:

The Elementary Curriculum/Supplemental Service/Summer School Department requests that the administration enter into purchase agreements with multiple vendors (see attachment A). The multiple vendors will provide supplemental after school tutoring in reading or math for students who score 50 percent or below on the Metropolitan Achievement Test, or any third- through eighth-grade student that receives a basic or lower score on the Ohio Achievement Test.
